WHO WE ARE

IO Esports (ioesports.gg) respects the privacy rights of our users and is committed to protecting the information collected through its products, services, and websites accessed through any internet-capable hardware platform including personal computers, mobile computers, smartphones, or in-game applications or any software platform including Online Services. IO Esports recognizes the importance of protecting information collected from users and has adopted this privacy policy to inform users about how IO Esports gathers, stores, and uses information derived from their use of IO Esports products, services and online sites.

WHAT INFORMATION DOES IO ESPORTS COLLECT?

1. Personal/Non-personal Data

We may collect and process the following data about you:

- a) information that you provide us with when you fill in forms when accessing and/or using our Services, or when you create an account with us;
- b) details of your use of our Services and the resources that you access (for example, information about how and when you visit our Website, what device you use to access our Services.
- c) if you contact us or respond to messages and communications that we send to you, we may keep a record of that correspondence; your interactions with us on our social media channels such as Facebook and Instagram
- d) we may obtain information about you from third parties who hold data about you and who agree to share this data with us; and
- e) information we collect via cookies and other similar technologies, as explained further below.

2. Cookies & Advertising

We use cookies and other similar technologies in our Services. These technologies operate either by (i) placing a small file which stores some information on your computer or mobile device; and/or (ii) by accessing information on your device. We use cookies and similar technologies:

- a) to allow us to recognize you and your device, for example by identifying your IP address;
- b) to allow our Services to interact with a third-party social network or platform (where you have chosen to allow such interaction);
- c) to allow our payment processors to process your payment instructions;
- d) to enable us and third parties to provide you with more customized services, for example to provide our services in the correct language or to enable the provision of more relevant advertising to you; and
- e) to collect data such as: your device's model, operating system and screen size, the other applications installed on your device, and information about how you use our Services.

By accessing and/or using our Services you consent to our use of cookies and similar technologies in accordance with this Privacy Policy. HOW WILL WE USE YOUR PERSONAL INFORMATION?

- b) managing your account and relationship with us and improving your experience when you use our Services;
- c) improving our Services, for example by helping us fix bugs or by providing Services updates;

WILL WE SHARE YOUR PERSONAL INFORMATION WITH THIRD PARTIES?

- b) as reasonably necessary in order to provide the Services to you (for example, by providing your Personal Information to suppliers we may use to fulfil the Services or to communicate with you);
- c) where it is necessary to carry out your instructions (for example, to process a payment instruction we must provide your Personal Information to our payment processors);
- d) where your data is on an anonymous and aggregated basis, meaning you could not be personally identified from it;
- e) when you submit information as part of a competition or otherwise interact with our social media channels (for example, by providing a testimonial about one of our Services) we may publish the information you submitted, alongside your name and home country on our website(s) and social media channels;
- f) as we reasonably believe is permitted by law or regulation;
- g) in order to comply with any legal obligation, or in order to enforce or apply our terms and conditions and/or any other agreement with you; or to protect the rights, property, or safety of IO Esports, our users, or others;
- h) in the event that there is a sale of the assets of IO Esports or corporate restructuring, or as a result of a change of control of IO Esports or one of its group companies, or in preparation of any of these events. Users of our Services may be automatically assigned a profile which is visible to other users of our Services. Your profile may include your username, photos, or other game play information and details of which other IO Esports account holders have viewed your profile. Your profile will be visible to other users of our Services.

FOR HOW LONG WILL WE RETAIN YOUR INFORMATION?

We will retain your Personal Information for as long as is necessary to fulfil the purposes for which it was collected or as needed to provide you with Services. We may retain your Personal Information after you have closed any account you have with us or after we have stopped providing Services to you if retention of your Personal Information is reasonably necessary to comply with our legal obligations, meet regulatory requirements, resolve disputes between members, prevent fraud, cheating or abuse, or enforce this Privacy Policy or any other agreement we may have with a use

HOW LONG WE RETAIN YOUR DATA?
